COLLEGE ACCESS PROGRAM

Currently, only 7% of undocumented high school graduates attend college nationally



The College Access Program (CAP) provides essential resources for undocumented high school students and high school staff in order to maximize access to a quality and affordable college education. The program envisions many levels of support for students, families, teachers and guidance staff both with the college process and legal representation. There have been more than 200 attendees at CAP events to date.

DACA & IMMIGRATION REFORM

In the event that President Obama's Deferred Action for Childhood Arrivals (DACA) policy is revoked, UnLocal staff and attorneys will continue to collaborate with DACA recipients and allies to secure other immigration benefits in the fight against threats of deportation.



We will continue to fight for comprehensive immigration reform, and push back against regressive change that threatens to divide our communities.

2017 FOCUS: EDUCATIONAL OUTREACH



2016 - 2017 SCHOOL YEAR

Collaborate with at least **15** different high schools. UnLocal is currently working with the Internationals Network for Public Schools, the New York City Department of Education, and college access partners to expand the project. UnLocal staff and its volunteers are expected to impact **400+** students through the partnerships with these **15** schools and **25** guidance counselors.



COLLEGE ACCESS PROGRAM

In 2017, UnLocal staff will work with guidance counselors, students and families on how to apply and finance college as an undocumented student or a student from a mixed immigration status family. The project involves presentations to guidance counselors and other support staff at high schools.

2017 FOCUS: FOLLOWING THE ELECTION



UnLocal's mission to provide legal representation, consultations and community education for immigrants has become more important than ever before. The current administration poses a significant threat to immigrants who are seeking legal status and remaining in the United States with their loved ones.

We are looking to expand our capacity in 2017, and will work to ensure that New York City remains a welcoming place for any and all Americans.

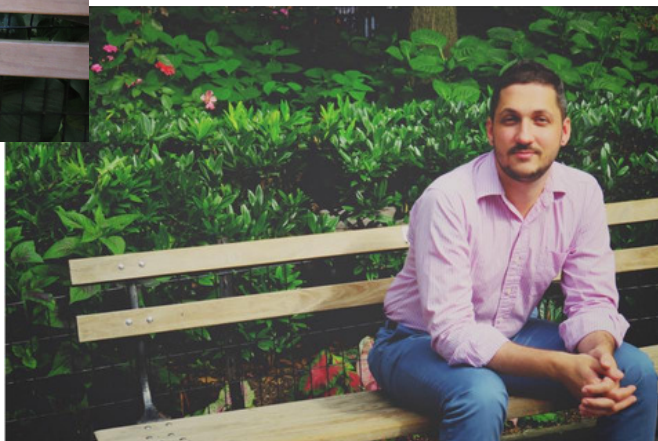

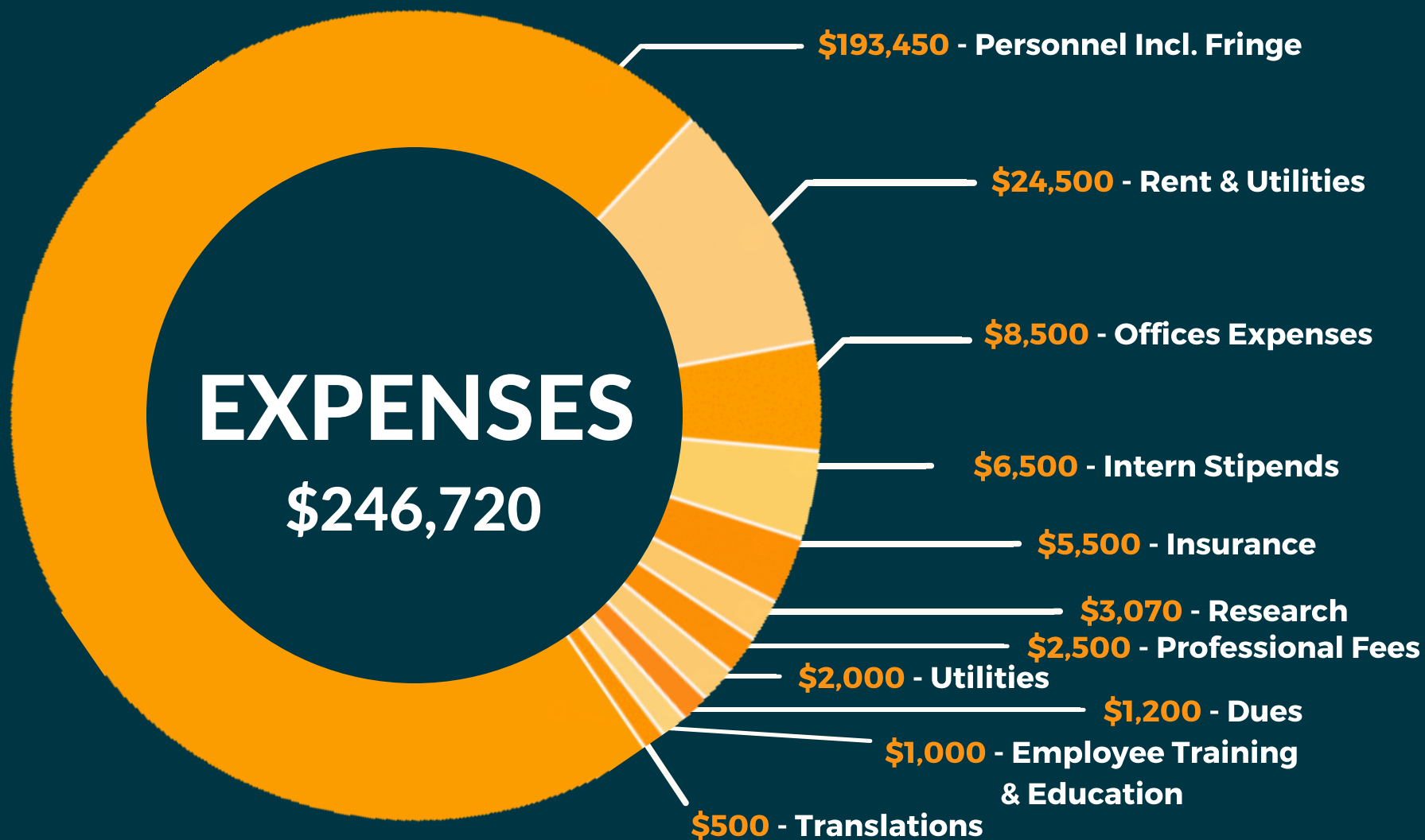

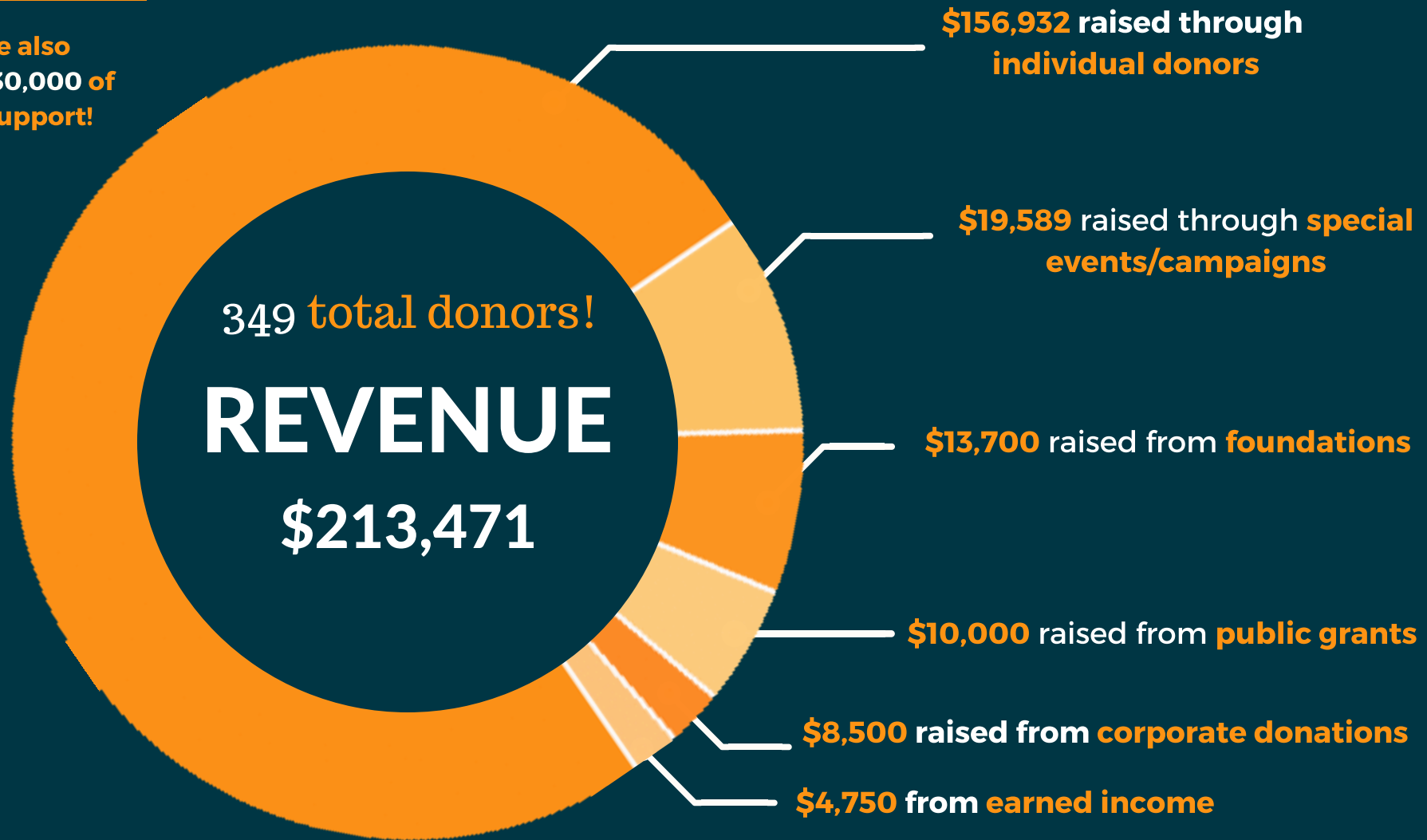
