

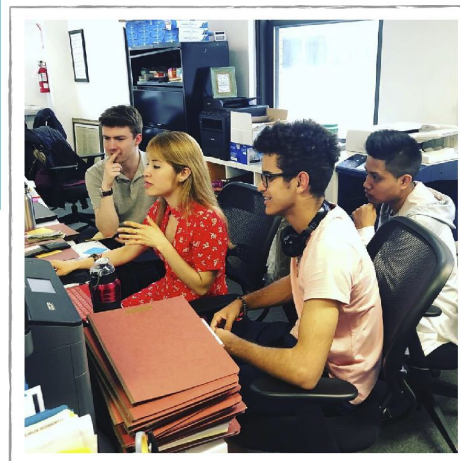
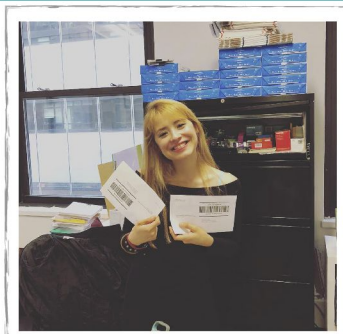


## UnLocal's Collaborators

## Legal Representation Program

UnLocal's Legal Representation Program changes in real-time to reflect the needs of the immigrant communities we serve in New York City. UnLocal's five full-time legal team members works to represent clients and travel throughout the five boroughs to assist immigrants with their cases. UnLocal works with immigrants of all ages and backgrounds, with an emphasis on undocumented immigrants.

## Community Education Program

UnLocal's Community Education Program partners with community-based organizations, primary and secondary schools, workplaces, houses of worship and community groups to bring free legal consultations and educational seminars into immigrant communities. Topics at events revolve around current events in immigration law. UnLocal has over 70 community-based partners to deliver these resources.

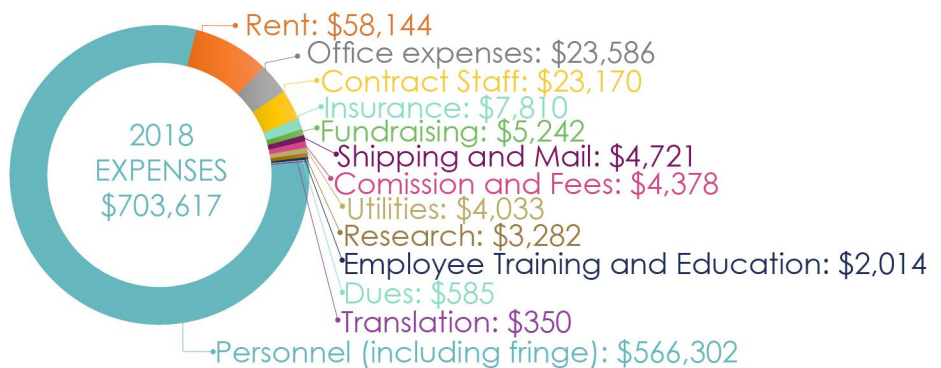
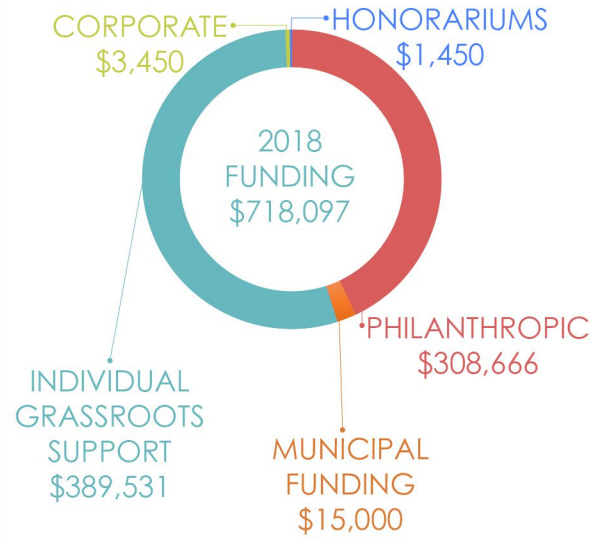
