What is Advance Parole?



Travel document issued by the USCIS



Allows certain immigrants to travel outside of the U.S. and return lawfully



Does not replace passport or visas you will need to travel abroad

Who is eligible for Advance Parole?

- 1. DACA Recipient
- 2. Asylum / refugee status
- 3. Pending Green Card
- 4.Other types of immigration applicants pending or approved

Who may NOT be eligible for Advance Parole?

- 1. Prior deportation order/removal order
- 2. Pending DACA Application
- 3. Any criminal convictions
- 4. Immigration-related fraud or misrepresentation
- 5. Undocumented

What are the benefits of Advance Parole?

 Allows approved applicant to travel outside the U.S. without risking their immigration status

• DACA Recipients: Re-entring the U.S. as a lawful entry

1-94 - LEGAL ENTRY

What are the risks of Advance Parole?

- 1. Application approval is NOT guaranteed
- 2. Possibility of denied reentry to the U.S.
- 3. AP document could be revokes while overseas
- 4. Always consult with an immigration attorney before leaving the country!



General Guidelines / Travel Tips



Inform people of your travel dates



Double check date on all stamps from CBP



Watch what you post on social media



Keep a list of emergency contacts & attorney info



Bring AP & DACA approval notices



Buy return flight 2-3 days prior to your AP expiration date



Leave copies of your approval notices with close relatives in the U.S.



Don't get arrested overseas
