This year, I made the decision to remain at UnLocal and transition from Interim Executive Director to Executive Director. After thoughtful consideration, I accepted because I deeply believe in our staff, our clients, our community, and our supporters. What we are building together at UnLocal is truly special, and I'm honored to continue leading this important work. We also expanded our legal team, allowing us to serve more clients with greater depth and care. We hired our first-ever Development Director that has allowed us to start tapping into new ways to raise sustainable funds.

In the past 12 months, we helped over 6,500 individuals stay informed and navigate complex legal systems—from asylum seekers to DACA recipients, trafficking survivors, detained families, and long-standing residents seeking citizenship. I'm proud to share that an Immigration Legal Fellow joined UnLocal late last year to support unaccompanied minors facing deportation. This initiative holds deep personal significance for me, as I experienced a deportation order firsthand as a teenager. That experience informs my understanding of the urgent need for robust, youth-centered legal and community support. I am proud that we are strategically expanding our capacity to advocate for young immigrants—ensuring they have access to the protections, resources, and opportunities they need to live with safety, dignity, and the ability to thrive.

As we look ahead to 2025, you can count on us to keep showing up—boldly, unapologetically, and with deep commitment. We carry with us a simple but powerful truth: every immigrant deserves their human rights to be respected, access to trusted legal support, and a real chance to thrive.

None of this would have been possible without you—our supporters, volunteers, partners, and staff. Together, we are building something powerful—community by community, case by case, person by person. Your belief in our mission fuels our work. Your generosity sustains it.



LEGAL PROGRAMS

UnLocal's legal programs provide comprehensive immigration representation and support services through four specialized initiatives that serve diverse immigrant communities across New York City.

In 2004, we handled 1,507 cases through four core legal service teams:


- **Post-Order Defense (POD)**: Provides legal representation for immigrants with removal orders, helping with appeals and motions to reopen cases.
- Pro Se Plus Project (PSPP): Helps individuals who are representing themselves in immigration proceedings by providing legal guidance, document preparation support, and educational workshops.
- Queer Immigrant Justice Project (QIJP): Specializes in legal services for LGBTQIA+ immigrants, with a focus on asylum cases and humanitarian relief.
- **Non-Detained Program**: Represents immigrants who are not in detention facilities, handling various cases including asylum applications, family petitions, and humanitarian visas.

TOP CASE MATTERS

The top most commonly handled case matters of 2024 included:

- Work Authorization applications (14.8%)
- Asylum applications (13.2%)
- Post Order Defense reviews (9.5%)

Other significant services included various motions and venue changes (3.4%), legal advice and counsel (2.1%), and social work services (1.3%). The remaining services (55.7%) encompass a wide range of immigration-related assistance including FOIA requests, TPS applications, DACA renewals, appeals, and specialized immigration petitions.

Post Order Defense (POD)

POST REMOVAL ORDER DEFENSE CASES IN 2024





The Post-Order Defense (POD) team provides legal representation to immigrants with removal orders, helping them navigate complex appeals and motions to reopen their cases. In 2024, the POD Team expanded its reach and strengthened its community impact through strategic new hires. A new attorney, fluent in additional languages, enabled the team to better serve West African communities. The team further enhanced its capacity when an Immigrant Justice Fellow joined to assist minors under 18—revitalizing the Special Immigrant Juvenile Status practice. The combined capacity building efforts resulted in the POD team's handling of **228 post removal order defense cases** by the close of 2024.

POD 2024 Trends and Impact

In 2024, post-election fears significantly increased intake calls concerning deportation. The POD team swiftly responded by offering emergency planning consultations, conducting ICE raid-focused "Know Your Rights" sessions, and advocating for supervised clients to prevent arrests. A notable success involved a client facing mandatory in-person ICE check-ins. Our team's thorough review uncovered potential U visa eligibility. Despite a previous failed motion to reopen, persistent advocacy and meticulous documentation led to a U visa determination, granting our client deferred action protection, temporary deportation relief, and legal work authorization. By proactively exploring diverse relief options, we consistently protected our clients' rights and safety.

Beyond this, the POD team achieved several key successes in 2024. These included reuniting a pardoned New Yorker with his U.S. citizen mother after facilitating his return from Haiti, and securing an emergency appeal win for an Indian asylum-seeker at Orange County Detention Center, enabling him to continue his asylum case."

POD Highlight

In December, the POD team organized their annual Holiday Letter Writing Circle, raising over \$1,000 for commissary stipends and connecting detained clients with support through letters and Know Your Rights sessions. The event brought together volunteers, the Undocumented Women's Fund, and LES Preparatory High School students.

Queer Immigrant Justice Project (QIJP)

The Queer Immigrant Justice Project (QIJP) team offers specialized legal services and support for LGBTQIA+ immigrants, focusing on asylum cases and other forms of humanitarian relief. In 2024, **QIJP handled 129 cases** for LGBTQIA+ identifying immigrants.

QIJP 2024 Trends and Impact


Amid intensifying harmful rhetoric against LGBTQIA+ communities in the lead-up to the 2024 election, QIJP redoubled its efforts to ensure LGBTQIA+ immigrants could access essential immigration benefits with dignity and respect. We also forged key partnerships with LGBTQIA+ organizations, empowering their communities through initiatives like our summer workshops at the LGBT Center, which addressed asylum processes, work authorization, and tax filing with ITINs. Our comprehensive volunteer training and legal clinics successfully engaged over 78 volunteers, educators, and community members.

CASES HANDLED BY QIJP IN 2024

Even in 2024's challenging political climate, QIJP proudly witnessed a number of LGBTQIA+ immigrant clients receive their green cards. For asylum winners, this often signals the end of months, or even years, of uncertain waiting, paving the way for a more secure life in the United States. As the federal administration's policy shifts continue to impact immigrant communities, QIJP anticipates increasing challenges for LGBTQIA+ individuals in 2025. Therefore, our priority remains steadfast: to deliver gender-affirming and culturally-competent legal services, while actively fostering a safe and supportive community space for our clients.



QIJP Highlights

The Queer Immigrant Justice Project (QIJP) celebrated a complex asylum win for a client. QIJP's client was a Transgender Woman from Mexico, which is often mistakenly perceived as an LGBTQIA+ progressive country. QIJP navigated this difficult case with compassion and expertise, proving to the immigration court that our client's life would be at risk if deported. She now feels at ease knowing she secured asylum and can begin a new chapter in New York City.

QIJP and our Education and Outreach Team also collaborated to organize UnLocal's June Cumbia Pride event. The event offered young people a fun and creative way to celebrate Pride in a safe space while enjoying dancing, music, and food. Cumbia dance instructor, Mark Saldana, led a beginners Cumbia class, and Cartoonist, Daisy Ruiz, performed a reading of her comic – *Gordita: Built Like This*.

The Pro Se Plus Project (PSPP)

The Pro Se Plus Project (PSPP) team assists individuals who represent themselves in immigration proceedings by providing legal guidance, document preparation support, and educational workshops. UnLocal is also a member of the PSPP collaborative, a network of seven legal services and community-based organizations working together to meet the high demand for Pro Se services across the five boroughs. This coalition includes UnLocal, Central American Legal Assistance, Catholic Migration Services, New York Legal Aid Group, African Communities Together, MASA, and Venezuelan and Immigrants Aid.

PSPP 2024 Trends and Impact

Throughout 2024, the UnLocal Pro Se Plus Project (PSPP) team managed a high volume of diverse legal assistance, serving 449 individuals. Our comprehensive support encompassed advice and counsel, affirmative and defensive asylum applications, Temporary Protected Status (TPS) applications, employment authorizations, and friend-of-the-court appearances. We also addressed urgent needs through numerous emergency filings to comply with court orders and crucial one-year asylum deadlines.

Despite facing significant challenges, particularly the overwhelming reality of community needs extending beyond our core services, PSPP remains deeply committed to our clients. Our team worked nonstop to manage follow-up tasks and provide ongoing support to a rapidly growing client base, ensuring no one was left behind.

The shifting political landscape, including the prospect of a second Trump Administration, presented additional hurdles. For instance, Secretary Noem's attempted cutoff of Venezuelan Temporary Protected Status access just before our January TPS clinic created immediate urgency. We closely monitored policy changes, such as the Biden-era 'circumvention of lawful pathways' rule impacting recent asylum applicants, and the Trump-era restrictions on parole access.

Looking ahead to 2025, PSPP will proactively map our client base and conduct strategic outreach. With announcements from the Trump administration to seek dismissals of certain removal cases—potentially subjecting individuals to expedited removal—we see a critical opportunity to equip potentially affected pro se respondents with the tools to defend their rights.

The Pro Se Plus Project (PSPP) continued

PSPP Highlights

UnLocal hosted **seven PSPP legal clinics** throughout 2024, providing vital on-site legal consultations that **served 84 individuals** in need. These clinics played a crucial role in expanding access to legal services, offering immediate guidance to community members navigating complex immigration processes. By meeting people where they are, these clinics helped break down barriers to legal representation and access to knowledge about immigrant rights and options.

PSPP represented a family from Jamaica who won asylum after being placed in witness protection when their cousin became a key witness in the Caribbean's largest gang prosecution case. Despite enduring four years of inadequate protection from their government and living in constant fear, the family persevered. "During the asylum hearing, our client testified eloquently about their experiences, maintaining remarkable composure even under intense cross-examination. This case highlights how the asylum system protects individuals failed by their home countries, giving this family an opportunity to build a new life in safety.

PSPP assisted a mother of four from Senegal fleeing severe domestic violence. After local authorities failed to protect her from her abusive husband, she sought asylum in the US. She contacted UnLocal for help with her Pro Se Asylum application, and we provided full representation while connecting her with trauma support services. For our client, legal support is crucial—her successful asylum application is literally a matter of life or death. If forced to return to Senegal, she faces death threats from her husband.

Non-Detained

Detained Legal team represents immigrants who are not in detention facilities, handling a wide array of cases including asylum applications, family petitions, and humanitarian visas. In 2024, our legal team assisted **701 non-detained individuals.**

Non-Detained 2024 Trends and Impact

Our primary emphasis in 2024 was removal defense for asylum seekers. Through dedicated advocacy, the team successfully completed 10 final hearings, resulting in over a dozen clients obtaining legal status in court. Beyond these court victories, many other clients received favorable USCIS decisions, encompassing Special Immigrant Juvenile Status, green cards, citizenship, affirmative applications, and work authorizations.

The inception of the Pro Se Plus Project (PSPP) significantly expanded the non-detained team's responsibilities, adding extensive application filings, screenings, and clinics. Despite this increased workload, the team maintained robust representation for their full-representation clients while effectively balancing pro se assistance through regular case docket review.

During UnLocal's internal restructuring to build capacity, the non-detained team demonstrated remarkable flexibility and a solution-oriented approach under collaborative supervision. The arrival of a new Legal Director later in the year further strengthened our internal systems and processes, driving significant operational improvements."

Non-Detained Highlights

- A bisexual Muslim client won his asylum case after surviving a mob attack! Having lost contact with his young son, they miraculously reunited and made it to the US together.
- A gay Jamaican client won asylum in immigration court despite having a complex background in his home country that could have jeopardized his case.
- A Nigerian youth, whose asylum case was dismissed from court, successfully obtained Special Immigrant Juveniles Status and will be eligible to adjust status within a few years.

In 2019, the Trump administration enacted the **Migrant Protection Protocols (MPP)**, commonly known as "Remain in Mexico," a policy that forced asylum seekers to wait in Mexico for their U.S. immigration court proceedings. Despite this challenging policy, our fierce team successfully secured asylum for two formerly MPP-impacted families in 2024, even in tough jurisdictions outside of New York.





RACE/ETHNICITY BREAKDOWN OF UNLOCAL CLIENTS




PRIMARY LANGUAGE PREFERENCES



EDUCATION + OUTREACH PROGRAM

UnLocal's Education & Outreach (E+O) Program provides vital community education and legal rights training through targeted workshops, informational sessions, and grassroots outreach initiatives that empower immigrant communities across New York City.

Key E+O initiatives include:

- Know Your Rights Workshops: Interactive educational sessions designed for immigrant communities, covering critical topics like emergency preparedness, legal protections, and available resources. These workshops are culturally responsive and delivered in multiple languages to ensure accessibility for diverse immigrant populations.
- NYS DREAM Act Assistance Program: Conducts outreach and presentations to inform educators, students, and parents about the New York State DREAM Act and its benefits. The program also directly assists students with completing and filing applications for NYS DREAM Act eligibility, the Tuition Assistance Program (TAP), and the Excelsior Scholarship.
- Community & Connection Series (CCS): Provides support to undocumented youth and community members who are interested in community building, resources for navigating career paths, skill based educational opportunities, and/or higher education.
- Open Hearts Open Arts (OHOA): Invites artists to speak, lead, and propose art-making events at UnLocal. We aim to create an open space for immigrant voices while following their creative and intuitive lead. The program emphasizes sharing meals, stories, resources, and joyful experiences together.

UnLocal E+O at the Multilingual NYCDOE Edu Conference

In 2024, E+O activities significantly expanded UnLocal's reach, engaging over 1,300 individuals through 46 in-person and hybrid events across key initiatives. Our digital presence also grew substantially, with newsletter subscribers and social media followers collectively reaching more than 7,000 people. This continuous growth demonstrates our increasing influence and ability to build stronger, more informed communities while amplifying our mission of support and advocacy across diverse platforms.

FORWARD WITH PURPOSE / EDUCATION + OUTREACH PROGRAM

E+O 2024 Trends and Impact

In 2024, the Education & Outreach team saw heightened demand for "Know Your Rights" and other immigration training sessions, particularly those designed to help educators and professionals at community-based organizations better serve immigrant community members. The team established valuable new partnerships with the Department of Education, Department of Multilingual Learners, the High Line, and DCTV. Although the high demand for these impactful presentations strained our capacity, the E&O team expanded their reach by strengthening collaborations with partner organizations—leading to connections with new communities and a more diverse audience.

E+O Highlights

In a remarkable success story from our CCS Career Pair & Share mentoring initiative, a determined New York State Dream Act student with healthcare aspirations connected with a physician assistant mentor who shared his inspiring journey as a former undocumented student. Fast forward to 2024, and we're thrilled to announce that she has transformed her dreams into reality – completing her certification and launching her career as a full-time physician assistant!

At our annual Immigrant Wellness Fair, we connected a new family and their baby with our partner El Puente, who provided essential support through formula, diapers, and resources for childcare and afterschool programs. Working together with partners to leverage community resources is one of the key ways we work to alleviate the economic insecurity many of our clients face.

UnLocal has been transforming immigrant connections through a vibrant community market initiative. Recognizing the need for safe, affordable vendor spaces, these dynamic markets have become thriving hubs of mutual growth and relationship building within our communities. In 2024 we partnered with DCTV Firehouse, where we brought together a diverse array of immigrant talent—eight enterprising small business vendors, four creative food vendors, and eight talented artists, including several of our own clients!

IMMIGRANT WELLNESS TEAM

Working closely with staff attorneys, the Immigrant Wellness Team (IWT) plays a crucial role in connecting clients to vital supplemental resources and therapeutic services. In 2024, IWT directly assisted 89 individuals with a wide range of social services case management and benefits procurement. This included guiding clients to therapy, identifying food pantries, navigating medical insurance applications, and linkage to community support groups.

The 2022 humanitarian crisis significantly exacerbated New York City's existing housing challenges, leading to widespread instability for newly arrived immigrants, who often faced overcrowded shelters and eviction. Compounding this, the mayor's closure of several major city shelters further intensified the housing crisis. This protracted crisis continued to impact communities throughout 2024. In response, the Immigrant Wellness Team (IWT) worked diligently to improve the stability of clients through shelter enrollments, vigorous housing advocacy, and by securing vital rent and utility arrears.

Beyond direct housing support, IWT also observed a critical gap in social work services for new arrivals. To address this, the team **curated a comprehensive social services resource guide** in 2024. Additionally, IWT synthesized clients' experiences within shelters and actively navigated unjust policies, culminating in advocacy before the New York City Council against the Adams administration's detrimental 30/60-day shelter rule.

Despite these efforts, the main challenge in 2024 remained a persistent lack of capacity to meet the overwhelming needs of immigrant communities, particularly amidst a housing crisis with no immediate viable solutions or resources. The Immigrant Wellness Team responded to this distress by providing essential supportive counseling to clients experiencing eviction, housing insecurity, and fear regarding the incoming administration's potential impact on their livelihoods in the U.S.



Looking forward to 2025, IWT's primary goal is strategic growth. This includes expanding both our hiring efforts and our existing support services to comprehensively address evolving needs. We aim to better integrate social work directly into our legal practice, streamline the social work role within the Post Order Defense Team, and onboard more social work interns, further enhancing our holistic client support.

IWT Highlight


IWT worked with two high-needs clients for the past four years and supported them in coordinating their medical exams for their green card applications bringing their 8+ year journey seeking asylum (and with Unlocal) to a positive close. One of the two successfully earned Legal Permanent Resident status.



FINANCIALS

Income and Expenditures

In 2024, UnLocal managed a total operating budget of \$3,743,188.33 while generating \$4,002,827.33 in revenue. This revenue surplus is crucial for building our **operating reserve**, strengthening our financial resilience, and ensuring the **sustainability of services** even in an unpredictable funding climate."
